### STATUTE CCCLXXII/REACHT CCCLXXII

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University./*Faoi agus de bhua na gcumhacht sin a bheirtear dúinn ag na hAchtanna thuasluaithe, déanaimidne, Údarás na hOllscoile ag Ollscoil na hÉireann, Gaillimh, tríd an ionstraim seo faoi Shéala Ollscoil na hÉireann, Gaillimh, an Reacht atá sa Sceideal seo thíos chun rialú ginearálta na hOllscoile sin.*

### Schedule – STATUTE CCCLXXII/*Sceideal* – REACHT CCCLXXII

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth./*Déanfar Reachtanna uile Ollscoil na hÉireann, Gaillimh, roimhe seo a léamh agus a fhorléiriú maille leis na hathruithe, na breisithe agus na modhnuithe atá leagtha amach ina dhiaidh seo thíos.*

## CHAPTER I

### THE DEPUTY PRESIDENT & REGISTRAR

1. Statute CCCXXX Chapter 1, is hereby amended by the removal of the phrase ‘and who had pensionable employment in the public service at some point in the twenty six weeks prior to his/her appointment’.
2. Statute CCCXIII, Chapter I, Section 9, and Statute CCCXXI, Chapter 1, are hereby amended by the substitution of the following Section for the above named Section and Chapter therein:

“The Deputy President & Registrar, acting under the general direction of the President, shall

- a) subject to the overall responsibility of the Academic Council for the academic affairs of the University, be responsible, following due consultation with the University Management Team, for academic planning and for the formulation of academic policy, together with the continuous review and monitoring of its implementation.
  - b) arrange for the implementation of the decisions of the Academic Council and for the transaction of all academic business arising in connection therewith
  - c) be responsible for Student Services and Sport
  - d) do all such other acts and perform all such other duties in relation to the academic business of the University as(s) he may be required by the President and by Údarás na hOllscoile to do or perform.”
3. Statute CCCXIII, Chapter 1 is hereby amended by the substitution of the following Section for Section 10 therein:

“The Deputy President & Registrar, under the direction of the President and in accordance with policy determined by Údarás na hOllscoile, shall have responsibility for the formulation, in consultation with Acadamh na hOllscolaíochta Gaeilge and other University offices and personnel, implementation and monitoring of the University’s policy and procedures in fulfilment of its strategic and legal commitments to the role of the Irish language in the University.”
  4. Statute CCCXIII, Chapter 1, Section 10 is hereby renumbered as Section 11.

## CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the eleventh Day of March, Two Thousand and Twenty, and may be cited as Statute CCCLXXII, National University of Ireland, Galway, or Stat. CCCLXXII, Nat. Univ. of I., Galway.

## CAIBIDIL I

### AN tUACHTARÁN IONAID & MEABHRÁNAÍ

1. Déantar Reacht CCCXXX Caibidil 1 a leasú leis seo tríd an bhfrása ‘agus a raibh fostáiocht phinseanach aige/aici sa tseirbhís phoiblí am ar bith thar tréimhse fiche agus a sé seachtainí sular ceapadh é/i’ a bhaint.
2. Déantar Reacht CCCXIII, Caibidil 1, Alt 9, agus Reacht CCCXXI, Caibidil 1, a leasú leis seo tríd an Alt seo a leanas a chur in áit an Ailt agus na Caibidle thuasluaite:

“Beidh an tUachtaráin Ionaid & Meabhránaí, ag feidhmiú faoi stiúir ghinearálta an Uachtaráin,

- e) faoi réir fhreagracht iomlán na Comhairle Acadúla as gnóthaí acadúla na hOllscoile, freagrach as, i ndiaidh comhairliúcháin chuí le Foireann Bainistíochta na hOllscoile, pleanáil acadúil agus as polasaí acadúil a cheapadh, mar aon le hathbhreithniú agus monatóireacht leanúnach a dhéanamh ar a chur i bhfeidhm.
- f) freagrach as cinntí na Comhairle Acadúla a chur i bhfeidhm agus as gach gnó acadúil a eascraíonn as sin a chur i bhfeidhm leis seo
- g) freagrach as Seirbhísí na Mac Léinn agus Spórt
- h) freagrach as gach gníomh eile a dhéanamh agus gach dualgas eile a chomhlíonadh i ndáil le gnó acadúil na hOllscoile de réir mar a éilíonn an tUachtaráin agus Údarás na hOllscoile é a dhéanamh nó a chomhlíonadh.”

3. Déantar Reacht CCCXIII, Caibidil 1 a leasú leis seo tríd an alt seo a leanas a chur in áit Alt 10:

“Beidh an tUachtaráin Ionaid & Meabhránaí, faoi stiúir an Uachtaráin agus de réir polasaí a chinnfidh Údarás na hOllscoile, freagrach as ceapadh, i gcomhairle le hAcadamh na hOllscolaíochta Gaeilge agus le hoifigí agus pearsanra eile na hOllscoile, cur i bhfeidhm agus monatóireacht a dhéanamh ar pholasáí na hOllscoile agus nósanna imeachta i gcomhlíonadh a dualgas straitéiseach agus dlíthiúil i leith ról na Gaeilge san Ollscoil.”

4. Déantar Reacht CCCXIII, Caibidil 1, Alt 10 leis seo a athuimhriú mar Alt 11.

1. Ní dhéanfaidh aon ní anseo difear d'aon cheapachán a rinneadh, d'aon cheart a fuarthas ná d'aon ghníomh a rinneadh faoi aon Reacht den Ollscoil roimhe seo.
2. Tiocfaidh an Reacht seo i ngníomh an t-aonú lá déag de Mhárta, Dhá Mhíle agus a Fiche, agus féadfar Reacht CCCLXXI, Ollscoil na hÉireann, Gaillimh, a ghairm de, nó R. CCCLXXI, O. na hÉ., Gaillimh.
