STATUTE CCCXXXIX/REACHT CCCXXXIX

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University./*Faoi agus de bhua na gcumhacht sin a bheirtear dúinn ag na hAchtanna thuasluaite, déanaimidne, Údarás na hOllscoile ag Ollscoil na hÉireann, Gaillimh, tríd an ionstraim seo faoi Shéala Ollscoil na hÉireann, Gaillimh, an Reacht atá sa Sceideal seo thíos chun rialú ginearálta na hOllscoile sin.*

Schedule – STATUTE CCCXXXIX/Sceideal – REACHT CCCXXXIX

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth./*Déanfar Reachtanna uile Ollscoil na hÉireann, Gaillimh, roimhe seo a léamh agus a fhorléiriú maille leis na hathruithe, na breisithe agus na modhnuithe atá leagtha amach ina dhiaidh seo thíos.*

CHAPTER I

PERSONAL PROFESSORSHIP

1. There is hereby established in the University the following Personal Professorship:

Personal Professorship of Endocrinology.

2. The holder of the foregoing Personal Professorship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant in Endocrinology to be established in conjunction with the said Personal Professorship by the Health Service Executive in the University /Merlin Park Regional Hospitals, Galway. In the event that the holder of the Personal Professorship ceases to hold the said office of Consultant in Endocrinology, (s)he shall thereby be deemed to have resigned from the said Personal Professorship.
3. The holder of the said Personal Professorship shall devote 24% of his/her time to the duties of the said Personal Professorship and 76% of his/her time to the duties of the foregoing office of Consultant in Endocrinology.
4. The annual stipend attaching to the said Personal Professorship shall be the salary attaching from time to time to joint fulltime Academic Medical Consultant Associate Professor appointments. It shall be payable in its entirety by the Health Service Executive.
5. The holder of the said Personal Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
6. The said Personal Professorship shall be a pensionable office in accordance with the relevant pension scheme provisions operated by the Health Service Executive in respect of Academic Medical Consultant Associate Professorships. The pension shall be payable in its entirety by the Health Service Executive.
7. Subject to the terms of the Employment Control Framework currently in operation in the Health Service Executive under direction from the Department of Health or as such terms may be amended hereafter, the holder of the said Personal Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years: PROVIDED that (1) in the case of an appointee who is deemed to be a 'new entrant' to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004 and who had pensionable employment in the public service at some point in the twenty six weeks prior to his/her appointment, shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years, or (2) in the case of an appointee who is deemed to be a 'new recruit' from 1 January, 2013 to the public service in accordance with the provisions of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, shall not be entitled to retire before attaining the age of sixty-six years from 1 January, 2014, rising in line with the statutory state pension age to sixty-seven years from 1 January 2021 and sixty-eight years from 1 January 2028 and shall not be obliged to retire before attaining the age of seventy years.

8. The holder of the said Personal Professorship shall carry out the duties of the Personal Professorship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER II

SENIOR LECTURESHIP IN ENDOCRINOLOGY

1. There is hereby established in the University the following Senior Lectureship:

Senior Lectureship in Endocrinology.

2. The holder of the foregoing Senior Lectureship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant in Endocrinology to be established in conjunction with the said Senior Lectureship by the Health Service Executive in the University /Merlin Park Regional Hospitals, Galway. In the event that the holder of the Senior Lectureship ceases to hold the said office of Consultant in Endocrinology, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.
3. The holder of the said Senior Lectureship shall devote 24% of his/her time to the duties of the said Senior Lectureship and 76% of his/her time to the duties of the foregoing office of Consultant in Endocrinology.
4. The annual stipend attaching to the foregoing Senior Lectureship shall be the salary attaching from time to time to joint fulltime Academic Medical Consultant Senior Lecturer appointments. It shall be payable in its entirety by the Health Service Executive.
5. The holder of the said Senior Lectureship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
6. The said Senior Lectureship shall be a pensionable office in accordance with the relevant pension scheme operated by the Health Service Executive in respect of Academic Medical Consultant Senior Lectureships. The pension shall be payable in its entirety by the Health Service Executive.
7. Subject to the terms of the Employment Control Framework currently in operation in the Health Service Executive under direction from the Department of Health, or as such terms may be amended hereafter, the holder of the said Personal Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years: PROVIDED that (1) in the case of an appointee who is deemed to be a 'new entrant' to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004 and who had pensionable employment in the public service at some point in the twenty six weeks prior to his/her appointment, shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years, or (2) in the case of an appointee who is deemed to be a 'new recruit' from 1 January, 2013 to the public service in accordance with the provisions of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, shall not be entitled to retire before attaining the age of sixty-six years from 1 January, 2014, rising in line with the statutory state pension age to sixty-seven years

from 1 January 2021 and sixty-eight years from 1 January 2028 and shall not be obliged to retire before attaining the age of seventy years.

8. The holder of the said Senior Lectureship shall carry out the duties of the Senior Lectureship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER III

SENIOR LECTURESHP

1. There is hereby established in the University the following Senior Lectureship:

Senior Lectureship in Informatics

2. The annual stipend attaching to the foregoing Senior Lectureship shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.
3. The said Senior Lectureship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway
4. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holder of the said Personal Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years: PROVIDED that (1) in the case of an appointee who is deemed to be a 'new entrant' to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004 and who had pensionable employment in the public service at some point in the twenty six weeks prior to his/her appointment, shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years, or (2) in the case of an appointee who is deemed to be a 'new recruit' from 1 January, 2013 to the public service in accordance with the provisions of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, shall not be entitled to retire before attaining the age of sixty-six years from 1 January, 2014, rising in line with the statutory state pension age to sixty-seven years from 1 January 2021 and sixty-eight years from 1 January 2028 and shall not be obliged to retire before attaining the age of seventy years.
5. The holder of the said Senior Lectureship shall carry out the duties of the Senior Lectureship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER IV

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the sixteenth Day of December, Two Thousand and Fourteen, and may be cited as Statute CCCXXXIX, National University of Ireland, Galway, or Stat. CCCXXXIX, Nat. Univ. of I., Galway.
